Policy Measures taken by Income Tax in view of COVID-19

- Extended last date for income tax returns for (FY 18-19) from 31st March, 2020 to 30th June, 2020.
- Aadhaar-PAN linking date to be extended from 31st March, 2020 to 30th June, 2020.
- For delayed payments of advance tax, self-assessment tax, regular tax, TDS, TCS, equalization levy, STT, CIT made between 20th March 2020 and 30th June 2020, reduced interest rate at 9% instead of 12%/18% per annum (i.e., 0.75% per month instead of 1/15 percent per month) will be charged for this period. No late fee/penalty shall be charged for delay relating to this period.
- Vivad se Vishwas scheme no additional 10% amount, if payment made by June 30th 2020. (Vivad se Vishwas scheme-objective is to collect tax and reduce litigation. It offers a complete waiver on interest and penalty to the taxpayers who pay their disputed taxes on or before March 31st 2020)
- Due dates for issue of notice, intimation, notification, approval order, sanction order, filing of appeal, furnishing of return, statements, applications, reports, any other documents etc. expiring between 20th March 2020 to 29th June 2020 shall be extended to 30th June 2020.

Measures taken by MCA in view of COVID-19

- Companies (Auditor's Report) Order 2020 (CARO, 2020) will be made applicable from FY 2020-21 instead of FY 2019-20, benefiting the companies and its statutory auditors.
- Any director of a company who has not stayed in India for more than 182 days will still be considered as a resident of India in compliance with the provisions 149 of Companies Act 2013.
- Section 4 of the Companies Act, 2013 is not considered to be violated if the independent directors of a company could not hold their exclusive meeting during the FY 2019-20.
- The conduct of the board meetings by the companies within an interval of 120 days is now extended by a further period of 60 days until the next two quarters, i.e. 30th September 2020.
- The newly incorporated companies will get an additional 6 months for filing the Declaration Form for the commencement of business.
- A moratorium period has been defined from 1st April 2020 till 30th September 2020 during which companies and LLPs need not pay any additional

- fees for any late filing of documents/returns/ statements, irrespective of its due dates.
- MCA has relaxed the requirements of holding board meetings requiring physical presence of directors till 30th June 2020.
- The following requirements have been postponed from 30th April 2020 to 20th June 2020:
 - ✓ Creation of a deposit reserve containing at least 20% of deposits maturing in the FY 2020-21
 - ✓Investment of 15% of debentures maturing in a specific year in specified instruments.
- The contribution made by companies to the PM CARES Fund qualifies as admissible expenditure towards fulfilling CSR obligation under Companies Act 2013.
- MCA has introduced a web -based compliance form CAR 2020 (Companies Affirmation of Readiness towards COVID 19) in order to assess the readiness of companies in view of COVID 19 outbreak.

Relaxations under GST in view of COVID-19

NOTIFICATION - 30/2020 - CENTRAL TAX (03.04.2020)

1. Any registered person who opts for Composition Scheme for the FY 2020-21 shall file:

GST CMP-02	Filing of Intimation	30.06.2020
GST ITC-03	Furnishing of Statement of Reversal of Input	31.07.2020

2. Capping of ITC (10%) on the basis of Form GSTR 2A, shall apply cumulatively for the period from Feb, Mar, April, May, June, July & Aug 2020 and the return in Form GSTR 3B for Sep 2020 shall be furnished with cumulative adjustment of input tax credit for the said months in accordance with the conditions under Rule 36(4).

NOTIFICATION - 31/2020 - CENTRAL TAX (03.04.2020)

The Central Government has waived/reduced the interest payable on delay in filing GSTR 3B subject to the conditions as follows:

NOTIFICATION - 32/2020 - CENTRAL TAX (03.04.2020)

The Central Government has waived the late fees on delay in filing GSTR 3B returns for the tax periods Feb - April 2020 provided the returns are filed within the date provided in the above table.

NOTIFICATION - 33/2020 - CENTRAL TAX (03.04.2020)

The Central Government has waived the late fees payable on delay in filing GSTR 1 return for the months of March 2020, April 2020 & May 2020 and for the quarter ending 31.03.2020 provided the returns are filed on or before 30.06.2020.

NOTIFICATION - 34/2020 - CENTRAL TAX (03.04.2020)

The Central Government has extended the due dates of furnishing the following forms by the taxpayers registered under composition Scheme:

NOTIFICATION - 35/2020 - CENTRAL TAX (03.04.2020)

- 1. Where, any time limit for completion or compliance of any action, by any authority or by any person has been specified in, or prescribed or notified under the said Act, which falls during the period from the 20th day of March, 2020 to the 29th day of June, 2020, and where completion or compliance of such action has not been made within such time, then, the time limit for completion or compliance of such action, shall be extended up to the 30th day of June, 2020.
- 2. An e-way bill generated, the validity of which expires between 20.03.2020 & 15.04.2020, shall be deemed to have been extended till 30.04.2020.

NOTIFICATION - 36/2020 - CENTRAL TAX (03.04.2020)

The Central Government has extended the due date for filing GSTR 3B return for the month of May 2020 as follows:


